#### F.O.H.T.A. OUTLOOK

The Trespass to Property Act

This new Act is designed to give owners greater control over the use of their property and to increase fines for trespassing.

The Act provides that every person who is not acting under a right or authority conferred by law and who,

without the express permission of the occupier, the proof of which rests on the defendant,

- enters on premises when entry is prohibited under this Act; or
- engages in an activity on premises when the activity is prohibited under this Act; or
- does not leave the premises immediately after he is directed to do so by the occupier of the premises or a person authorized by the occupier.

is guilty of an offence, and upon conviction is liable to a fine of not more than \$1,000.

The Act also deals with the type of property protected, compensation for damages incurred, costs in prosecuting and the entitlement of the occupier to authorize any person to enforce the arrest procedures, where necessary. The owner of rural land permitting a trail association to establish a limited-use recreational trail over his land may wish to authorize members of the association to exercise his powers as occupiers under the Act.

The strength of any organization -- particularly one like the Rideau Trail Association which is composed of volunteers -- lies in the dedication of its members and in its relations with its community. For the Rideau Trail Association community relations are especially critical. Because of the linear nature of the Trail itself, and its length (second longest in the province, after the Bruce Trail), we have to consider not one but several communities, including two major cities a hundred miles apart (by road), two towns separated from the trailheads by fifty miles, and a number of smaller communities in between. It is vital to the success and continued feasibility of the Trail that we maintain our image of responsibility in the eyes of the public; our dependence on the generosity of private landowners for much of the Trail's right of way demands it. The amount of work involved in the administration and maintaining of two hundred miles of Trail requires a large and active membership. In the past the Rideau Trail members have been well-served by their local and Association executives and those who have volunteered to clear and maintain the Trail, but the membership base needs to be expanded to establish a wider pool from which to draw personnel, so that respite can be given to those long-time contributors who feel the need of a break.

The role of the Publicity Coordinator, as it appears to me, is to try to keep the Rideau Trail and the goals and activities of the Rideau Trail Association before the public. This role is not only served through the media, but through imaginative concepts, such as the Rideau Trail window stickers, which involve the whole membership. As the new Publicity Coordinator, I would ask each and every member to participate in a personal publicity campaign for the Rideau Trail: as the opportunity arises, do not hesitate to talk about the Trail and the RTA; share information with your friends and neighbours and colleagues and, if they are interested, encourage them to join; pass the Newsletter around and invite friends out for the Club hikes; write about your Rideau Trail activities for the Newsletter.

Finally, I would ask you to keep your Club publicity members in Kingston and Ottawa, as well as myself, informed of significant Rideau Trail activities.

The Rideau Trail Association has achieved accomplishments to be proud of; we have to all work together to preserve and enhance those accomplishments.





An arrest is a grave imposition on another's liberty and should only be attempted if other options prove ineffective.

The new legislation also creates a colour marking system to permit occupiers to give notice of their intentions; i.e., red markings mean that any entry is prohibited and yellow markings mean that entry is prohibited except for certain activities. In addition, the new legislation recognizes the need for a symbol code to give legal meaning to signs. A sign naming an activity, or showing a graphic representation of an activity, gives notice that the activity is permitted or prohibited.


#### WILDWOOD, WILDFLOWER, WILDBERRY WAYS

For some time the four of us (Cathy Cutts, Joan Hughes, Joanna Koeslag and I) had been contemplating staying near Ottawa and walking in that area for a change (Cathy could then fill in some more red lines on her maps to signify a few more miles hiked along the trail). We got together early July and planned to book accommodation at a bed and breakfast farm near Carleton Place. A phone call confirmed there was space for us. \$18.00 approximately each for bed, breakfast, packed lunch and evening meal! Beat that!

#### July 12: Bells Corners to Fallowfield. Map 2

Warm, breezy, slightly cloudy. Left Kingston at 8:30 a.m.. We spotted a car at Fallowfield and drove on to Bells High School in the other and were walking by 11:15. Before we even started we were highly amused at being lost in the conservation area behind the school. We thought we were smart in trying to pick up the trail via the pumping station, but discovered it was not possible. We should have obeyed the map! After the false start, what a lovely day we had. ## July 13: O'Neill Road to Roger Stevens Road, Map 4

The gravel roads and tracks here were straight and long - easy walking. The road allowances lush with high grasses and very enjoyable. Lunch was amongst the oregano today - I think I'll

always recall the pungent warmth as we stretch out for a short relaxation session. What imagery to take into the winter months to come!



Our day ended at around 2:00, as there were things to be done back home in Kingston that afternoon.

#### BIBLE STUDY IN THE MARLBOROUGH FOREST

What does the bible say about man's relation to the environment? This was one of the questions we tried to answer on Sunday, September 26, when Jennifer and I led 30 teenagers and 5 adults from the Rothwell United Church Youth Group on a hike to the cabin in the Marlborough Forest.

While at the cabin, we conducted a short bible study. This was followed by a game in which half of the group was blindfolded. The rest of the group members acted as guides and helped the others to experience nature. The blindfolded players were encouraged to touch and smell different objects, and to listen to the sounds around them. After a few minutes, the roles were reversed.

After the game, the group reunited around the fireplace to share their experiences and to reflect on the game. Lunch was cooked over the campfire and then we hiked back out to the O'Neil side road. Everyone had an enjoyable time.

And what does the bible say about man and nature? We focused on two readings that day: Psalm 8: 1-9 and Galations 6: 7-10.

In Psalm 8, we learned that although man is small in size in comparison to the universe, God made man inferior only to Himself. And He appointed man as exploiter and caretaker of nature.

#### OUT IN WINTER

A few helpful hints for when you go out on your winter hike. Make sure your boots are slightly loose - this will give your toes room to move around and help them stay warm. Also, take a first aid kit, because injuries have a much more serious consequence in the winter conditions.

# First Aid Contents

2 compresses, 1 roll gauze, 1 role tape, pain pills, halazone tablets, sunscreen ointment, bandaids.

Remember any water taken with you will freeze, and if you plan to melt snow, take along some Halazone tablets to purify the water that you are drinking. Your body burns lots of energy keeping you warm, so take plenty of snacking foods. It is every hiker's duty to know the signs of Hypothermia, because this could lead to death.

Wool clothing is best put on in layers. If you get hot you can take a couple of layers off or, if you are standing around, a down-filled vest would be best.

#### THE OCCUPIERS' LIABILITY ACT

#### Basic Duty

The basic duty of occupiers in the new Act is that an occupier (owner or tenant) owes a duty to take such care as is reasonable to see that persons entering the premises, and the property brought on the premises by those persons, are safe.

If an occupier fails to take reasonable care, the law imposes civil liability for any injury that may result.

While the new law recognizes a basic duty of occupiers to provide reasonably safe premises, it also recognizes that entrants may freely choose to assume risks by taking the environment as they find it.

While the Occupiers' Liability Act establishes a basic duty of care, it also recognizes that this should not extend to the following type of entrants:

- 1. Entrant Who Willingly Assumes Risk.
- 2. Entrant for Criminal Purposes.
- 3. Non-Paying Recreational Entrants.
- 4. Others in general, all entrants who do not pay a fee for entry assume their own risks. Also included in the class of persons deemed by law to assume their own risk on rural land are trespassers where entry is prohibited under the Trespass to Property Act and entrants who are neither prohibited nor expressly permitted to enter or use the land.
